Due to the nature of golf being an outdoor activity, reasonable discretion will be applied when considering factors contributing to non-attendance.

In the instance of a single player making a booking on behalf of other users using the single name, that said person will be responsible for all player bookings.

In the instance of part of a group arriving (for example two players arriving for a booking of four), this will be recorded as a no-show against the booking name.

Users may not be entitled to a refund of credit note for pre-paid bookings in the instance of a "no-show".

A three-stage process for the management of "no-shows" with a rolling three (3) month period will be undertaken, as per below.

The user has the opportunity to provide reasonable explanation as to why a "no-show" instance should not be recorded at each stage.

Conditions

1 demerit point per person, per no-show will be allocated to the person who has made the booking.

Once a person has:

- 4 demerit points, this will trigger the first instance in the table below
- 6 demerit points, will trigger the second instance in the table below
- 8 demerit points, will trigger the third instance in the table below

First Instance (4 demerit points)	Courtesy check-in phone call to the user advising "no-show" instance has been recorded.
Second Instance (6 demerit points)	Email to user advising second instance of "no-show" recorded. Opportunity for player to advise of any contributing factors. Warning if third "no-show" instance recorded, booking privileges may be restricted as per terms and conditions.
Third Instance (8 demerit points)	Email to user advising third "no-show" instance recorded. Online booking privileges may be restricted for a period of up to 28 days.
